



## eco-INSTITUT-Label

### Schedule of fees

(Status: August 2023)

Fees occur as part of the evaluation phase (document review, sampling, if necessary inspection, laboratory testing) up to the point of issuance of the certificate, in the monitoring phase during ongoing certification (e.g. if follow-up assessments are necessary) and as a result of the use of the label. The calculation is based on an individual offer, taking into account the standard prices listed below. The classification into the fee categories is carried out when signing the contract on the basis of the information provided by the label holder and is queried anew every year.

#### Fees of testing and certification

The test of certifiability (document examination) costs 290 € (per product, net).

The laboratory testing and certification costs differ depending on the product group. The following standard rates apply (in case of several, similar products, we will prepare an individual offer):

In addition to the standard rates, the following fees apply, which may be additional (e.g. for inspections in non-European countries or for the extension of the right of use under a different name) or are used for the calculation of individual offers:

## Label usage fee

The eco-INSTITUT-Label can be used in product communication. For this, we charge an annual label usage fee.

This fee is based on the total annual turnover of the product marked with the eco-INSTITUT-Label.

The label usage fee is calculated annually in advance. The allocation to the corresponding fee category is done by self-classification of the manufacturer.
